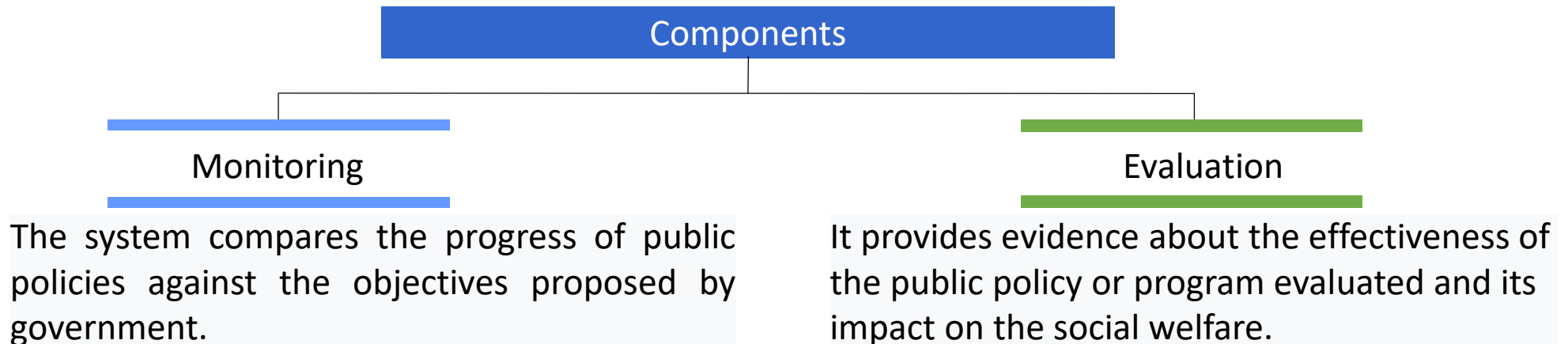

The Colombian National Evaluation System



The National System of Management Evaluation and Results (SINERGIA) was created to provide quality evidence about the National Public Policies in Colombia.



What does the agenda 2030 means for Colombia?



Colombia was one of the first countries on adopt the Agenda 2030 in the National Development Plan.



The agenda 2030 is a compendium of actions to improve the quality of life in Colombian population.



Helping to Colombian government to develop better public policies with long-term impact.

Integrating the global, national, local and sectorial work agenda regards to compliance of Sustainable Development Objectives.

How is the Agenda 2030 been implemented?



SDG High Level Commission



Unique institutional framework



Establish a national policy for the implementation of SDGs



SDG implementation strategy defined by CONPES 3918 consists of four pillars:



A monitoring and reporting scheme



A territorial strategy



Alliances with non-governmental actors



Access to open data for monitoring compliance with the Objectives

Why Evidence Matters for the Agenda 2030?



Having desired outcome is half part of the story

- We also need to know what actually works to achieving the Agenda 2030

Relevance of using research evidence to underpin the design of Public Policy



Practitioners and local institutions do not know how interventions can get them there

- Need of evidence of *what, how*
- Mainstream culture of evidence > low chances of finding credible evidence
