Young Evaluators have access in leveraging social media and other digital platforms for outreach and dissemination of evaluation findings is key at this 4IR. Therefore, are Young evaluators being often more attuned to long-term implications and are motivated to ensure that development efforts contribute to lasting positive change.

Involving Youth in Evaluation of Programs and Projects will enhance the ownership and acceptance of evaluation findings, leading to more effective implementation of recommendations. Hence, Understanding the global young Evaluators is critical for policymakers, educators, and businesses.
